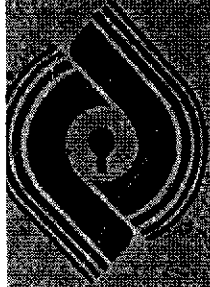

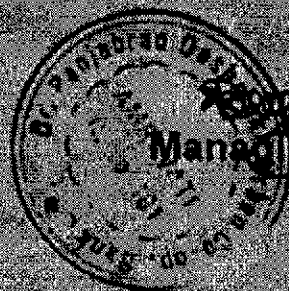

Scope of the activity:

In order to promote the culture of patenting and for creation of I.P. awareness among students and faculties of your institute, we have developed a special training, awareness and consultancy program.

Under this program, various I.P awareness and consultancy activities shall be organized for your institute who enter into yearly consultancy agreement. which shall include:

1. Weekly consultancy:

Our technical and legal expert will be available to provide consultancy and as well as any kind of assistance once in a week for one hour through video conferencing (at any predefined time mutually decided) where any of the students or staff member of the institute can interact with our team member in order to resolve any of their queries or clarifications in relation to I.P.R.

2. Quarterly training program:

A two hour basic I.P. awareness and training program shall be conducted every quarter through V.C. for interested students and faculties.

3. Yearly training program:

Following Program shall be conducted once every year at the institute by the trainers from BLI consultancy Pvt. Ltd. for creating awareness among the students and faculties of the institute.

Term:

The MOU shall come into effect from date of signing of the document and shall continue for the term of three years unless it is terminated earlier in accordance with the terms of this MOU. The agreement may be extended by a written and signed amendment.

Termination:

Either party may terminate this MOU on the other party's material breach of this MOU. The non-breaching party must give 30 days' written notice and opportunity to cure its breach.

Exclusivity:

All parties hereby agree that the MOU is entered on exclusive basis and either party shall not enter into similar agreements and arrangements with other parties also in relation to the cause covered under the said agreement without taking the consent of other parties in order to avoid any future conflict of interest.

Commitments:


Nothing in this Agreement shall give either Party the right to make commitments of any kind for or on behalf of the other Party without the prior written consent of the other Party. Either party to this agreement shall on request from the other return any document or items connected with the disclosure and not retain any un-authorized copies or likeness.

Indemnity:

The parties hereby agree and undertake to indemnify and hold harmless each other, their directors, officials, employees and agents from and against all and any claim, cause of action, liabilities and consequences which arise directly or indirectly from breach of this MOU or any neglect of wilful act, omission or misconduct, misrepresentation, cheating by defaulting party or any of its personnel or agent. For the sake of clarity, the foregoing indemnity provision shall also be applicable to any loss, damage, cost, suit, expenses or claims arising from violation of applicable law IPR obligations.


